## 2009 SHOTGUN OUTING PRICING

### **Monday – Thursday**

Minimum number of golfers is 36 for 9 Holes  
Starting time no later than 3:00 pm

Golf: 9 Holes with a cart on Regulation Course

Cost: \$15.00 per golfer

### **Friday**

Minimum number of golfers is 48 for 9 Holes (6 golfers per tee box)  
Starting time no later than 1:00 pm

Golf: 9 Holes with a cart on Regulation Course

Cost: \$17.00 per golfer

Earliest starting time is 11:00 am.

All weekend pricing is for golf only. Carts are given on a first come, first served basis. Carts cannot be "reserved" prior to event. We will make every attempt to make carts available to all of your outing guests. Sorry, there is no discounted pricing for carts on weekends. Payment for carts will be handled at Pro Shop counter with those players requesting carts. Please make sure to read the policy on payment for group greens fees.

# FOX RUN GOLF COURSE

## 2009 OUTINGS PROGRAM INFORMATION AND GUIDELINES

1. Outing dates will be awarded on a first-come, first-served basis. NO OUTINGS WILL BE BOOKED WITHOUT THE APPLICATION FORM.
2. All applicants will be notified of acceptance/non-acceptance within one week of receipt of formal request.
3. Season Passes and multi-round packages will NOT be accepted for group outings.
4. Outings are responsible for any damage to golf course and/or golf carts or injury to other golfers.
5. Outing golfers must follow all course rules including those pertaining to dress, pace of play, cart conduct, etc. Any violations of these or any other golf course rules will mean removal of such individual or individuals from the course without a refund.
6. Groups may make their own arrangements for catering service, however, Fox Run Golf Course must be informed of the arrangements.
7. **ALL BEVERAGES MUST BE PURCHASED FROM THE CLUBHOUSE OR REFRESHMENT CART. NO OUTSIDE BEVERAGES ARE PERMITTED!**
8. Outing representative or designated representative must be present at least **45 minutes** before event with Fox Run Golf Course staff to assist in identification/check-in of outing golfers. Outing representative must bring completed list of all registered golfers for check-in purposes.
9. Outing golfers must check-in at course at least **30 minutes** prior to first tee time.
10. Please make your golfers aware that Fox Run Golf Course does not have a cash machine.

### **Payment**

In order to receive special pricing, outings must be paid in one lump sum by outing representative, no less than 45 minutes prior to start of event. The number of golfers will be confirmed between golf course staff and outing representative at this time. Forms of payment accepted are cash, certified/corporate check, or credit card. Sorry, we cannot accept personal checks. Outings with less than the minimum number of golfers required for outing pricing will be charged a fee to make up the difference.
